

The following fees were set by the Government on 20 January 2005.

As well as giving you the rateable value of the premises, it will also show how the rates have been calculated. Rateable values of premises

1. Premises and club application and annual fees – each premises that is licensable will be allocated to a fee band according to rateable value

New application and variation fee

2. Each band attracts a different level of application and variation fee.

Annual Fees

3. Each band attracts a different level of annual fee – payable on each **anniversary** of the grant of the licence.
